However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The concerned Head of Department is requested to issue formal order for grant of the 3rd financial upgradation in respect of the above mentioned Officer working in the Department.
