In compliance of Hon'ble High Court Order Dated 23/08/2016 in the matter of W.P.C. No. 2766/2007 titled "Chief Secretary & Ors Vs Sh J. K. Bhatia and Hon'ble CAT Order Dated 12/01/2007 and on the recommendations of the Screening Committee constituted for grant of financial upgradation under the Assured Career Progression Scheme to Grade-III (DASS)/UDC official in accordance with the instructions contained in office memorandum no.35034/1/97-Estt.(D) dated 9.8.99 of Govt. of India, Ministry of Personnel, Public Grievances & Pension (Department of Personnel & Training), Secretary (Services) is pleased to grant 2<sup>nd</sup> financial upgradation under ACP Scheme to the following Official on completion of 24 years of regular service with one upgradation/ promotion from the existing pay scale of Rs 4000-6000 to next promotional hierarchy of Gr -II (DASS) Pay Scale of Rs. 5500-9000 (Pre-revised) w.e.t 31/07/2005:


Accordingly, the 2<sup>nd</sup> financial upgradation granted to the Official under MACP Scheme at Sr. No.171 of this Office Order No. 3 issued vide No.F.13(1)/2009/MACP-20/UDCs/Services/470-483 dated 22/02/2010 stands withdrawn with retrospective effect. Rest of the contents of the aforesaid order dated 22/02/2010 remains same.

The Official concerned may be allowed to exercise their options if any, under FR 22 within one month of the issuance of the Order granting the financial upgradation under the ACP Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage, the same will be recovered from their pay.

The Head of Department/Head of Offices are requested to ensure before issuing final order that the above officials fulfil the requirement as mentioned in point No. 4 and 5.1 of Annexure-1 of ACP Scheme introduced by DoPT, Govt. of India.


