ORDER 68

On the recommendations of the Screening Committee constituted for grant of financial upgradation under the Assured Career Progression Scheme to Grade-III (DASS)/Sr. Assistants in accordance with the instructions contained in Office Memorandum no. 35034/1/97-Estt.(D) Dated 9.8.99 of Govt. of India, Ministry of Personnel, Public Grievances & Pension (Department of Personnel & Training), Principal Secretary (Services) is pleased to grant 2nd financial upgradation under ACP Scheme to the following 01 Gr-III (DASS)/Sr. Assistant on completion of 24 years of regular service from the pay scale of Rs. 4000-6000/- (Pre-revised) to next higher grade in hierarchy of DASS Cadre of Rs. 5500-9000/- (Pre-revised) w.e.f. the date mentioned against his name :

The official concerned may be allowed to exercise his option, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage, the same will be recovered from their pay.

The concerned Head of Department is requested to issue formal orders for grant of 2nd financial upgradation in respect of the above mentioned official working in their Department. However, before the issuance of the formal orders the Head of department may again confirm that the official concerned has completed 24 years regular service with one promotion since the date of his initial appointment in the service and the official concerned is clear from vigilance angle.

The Head of Department concerned is requested to ensure before issuing final order that 24 years regular service of the official does not include the period of service rendered in State Government/Statutory Body/ Autonomous Body/Public Sector Organization as the period of past service in these bodies is not to be counted for grant of financial upgradation under ACP Scheme.

The official who are on deputation will get financial upgradation from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government .
