The official concerned may be allowed to exercise his option, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage, the same will be recovered from their pay.

The concerned Head of Department is requested to issue formal orders for grant of 2<sup>nd</sup> financial upgradation in respect of the above mentioned official working in their Department However, before the issuance of the formal orders the Head of department may again confirm that the official concerned has completed 24 years regular service with one promotion since the date of his initial appointment in the service and the official concerned is clear from vigilance
