Further, the Date of Eligibility for 3rd MACP benefits in respect of Ms. Santosh Raní has been re-viewed w.e.f 17.03.2017 and accordingly, this Department Order no. 72 dated 04.05.2018 stands modified to the effect that the date of Eligibility in respect of Ms. Santosh Rani may be read as 17.03.2017. Rest of the contents of the said order remains the same.

The Officer concerned may be allowed to exercise the option, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The concerned Head of Department is requested to issue formal order for grant of the 3rd financial upgradation in respect of the above mentioned Officer working in the Department. However, before the issuance of the formal orders the Head of Department may again confirm that the Officer has completed 30 years regular service with two promotion/financial upgradation and is clear from Vigilance angle.

The Officer on deputation will get financial upgradation from the date shown against the name only on notional basis, however, he will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of the repatriation to Delhi Government.
