On the recommendations of the Screening Committee constituted for grant of financial upgradation under the Assured Career Progression Scheme (ACP) to the then Grade-IV (DASS) Officials re-deployed from DEDA in accordance with the instructions contained in DoPT, Govt. of India O.M NO. 35034/1/97-Estt.(D) dated 09/08/1999, Circular dated 29.07.15 regarding counting of past service rendered at DEDA & the policy decision of the Department circulated vide letter dated 03.06.19, the Pr. Secretary (Services) is pleased to grant benefits of 1st financial up-gradation under ACP Scheme to following Official re-deployed from DEDA from the existing pay scale of Rs. 3050-4590/- (Pre-revised) to the next higher pay scale of Rs. 4000-6000 (pre revised) in the promotional hierarchy of DASS Cadre i.e. Grade III (DASS) w.e.f. the date mentioned against the name :

The 1st ACP benefits already granted to these Officials, if any, without counting of past services at DEDA/DSMDC stands modified accordingly.

The Official concerned may be allowed to exercise his option, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Assured Career Progression Scheme. However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from his pay.

The concerned Head of Departments are requested to issue formal orders for grant of the 1st financial upgradation in respect of the above-mentioned Official. However, before the issuance of the formal orders the Heads of Departments may again confirm that the official has completed 12 years of regular service with no promotion/ financial upgradation and are clear from Vigilance angle at the time of eligibility. Ad-hoc / temporary service period shall not be counted for grant of ACP benefits.
