ORDER NO. 14

On the recommendations of the Screening Committee constituted for grant of financial upgradation under the Modified Assured Progression Scheme to Gr.III (DASS)/UDC officials in accordance with the instructions contained in O.M. No. 35034/3/2008-Estt. (D) dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Pr. Secretary (Services) is pleased to nominate the following Gr.III (DASS)/UDC officials on the completion of 20 years regular service with one promotion or spent 10 years of continuous service in the same Grade Pay for grant of second financial upgradation from the corresponding Pay Band-T of Rs.5200-20200; Grade Pay of Rs.2400/- to the immediate next higher grade Pay of Rs.2800/- in the hierarchy of the recommended revised pay bands w.e.f. the dates mentioned against their names:-

The officials concerned may be allowed to exercise their option if any under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.

However, the grant of higher Grade Pay is subject to the undertaking that in the event of over payment, which may be detected at a later stage, the same will be recovered from their pay.

The Head of Department concerned is requested to ensure before issuing final order that 20 years of regular service or 10 years continuous in the same Grade Pay of the officials does not include the period of service rendered in State Govt./Statuary Body/Autonomous Body/Public Sector Organization as the period of past service in these bodies is not to be counted for grant of financial upgradation under MACP scheme (Point No. 10 of DoPT O.M. dated 19.05.09).

The concerned Head of Department are requested to issue formal orders for grant of the 2nd financial upgradation in respect of the above mentioned officials working in their Departments. However, before the issuance of the formal orders the Head of Department may again confirm that these officials have completed 20 years of regular service since the date of their initial appointment in the service or 10 years of regular service in the same Grade Pay and are clear from Vigilance angle.

The officials who are on deputation will get financial upgradation from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government.
