MINUTES OF THE MEETING OF THE SCREENING COMMITTEE HELD ON
19/12/2003 AND 12.1.2004 TO CONSIDER THE CASES FOR APPOINTMENT
ON COMPASSIONATE GROUNDS .

The Screening Committee for the purpose of considering cases for appointment on Compassionate Grounds was notified in September, 1997. The composition of the Committee is as follows:

1. Pr. Secy. (Trg. & Tech. Education)
2. Secretary (Education)
3. Secretary (Services)

A meeting of the Screening Committee was convened on 19.12.2003 at 11.00 AM in the Chamber of Pr. Secretary (TTE) and was continued on 12.1.2004 at 11.30 AM in the Chamber of Secretary (Services) to consider the cases of compassionate appointments on the basis of guidelines as given in the Compassionate Appointment Scheme which is governed by the Govt. of India guidelines as contained in the Scheme for Compassionate Appointment 1998 circulated vide DOPT OM No. 14014/6/94-Estt.(D) dated 9.10.98 and various judgements of the Hon'ble Supreme Court on the subject as referred to in the Scheme.

The Govt. of India vide DOPT OM No. 14014/6/95/Estt.(D) dated 26.9.95 restricted appointment on compassionate grounds upto a maximum of 5% of the vacancies available for the direct recruitment quota in any Group 'C' or 'D' post..

The Govt. of India vide OM No. 14014/19/2002-Estt(D) dated 5.5.2003 directed that the Committee may review genuine and deserving cases, rejected earlier due to non-availability of regular vacancies. The maximum time a persons name can be kept under consideration for offering compassionate appointment will be three years subject to the condition that the prescribed Committee has reviewed and certified the penurious condition of the applicant at the end of the first and the second year. Besides, it has been decided by the Government to adhere to the following criteria while considering the cases for appointment on compassionate grounds: -

1. The first priority would be for families, which are living in extremely indigent circumstances and having all children who are less than 12 years of age and no other source of livelihood e.g. rent, ownership of house, land, belonging of relative values etc.
2. Next consideration can be given to cases where the family is in extremely indigent circumstances and has minor children less than 18 years of age and no other source of employment.



2. To consider whether any of the earlier rejected cases fall under the criteria of OM No. 14014/19/2002-Estt.(D) dated 5.5.2003 of Govt. of India.

The details of all the cases and vacancies available were placed before the Screening Committee. The Committee taking a holistic and pragmatic approach, was of the unanimous decision to adhere to the following :-

1. Young widows with young children and no where to go deserve far greater consideration as compared to a family where there is already an earning member or a male member who is on the threshold of being able to becoming self employed. Of these widows having young daughters deserves far greater sympathy. Similarly, the applicants who have obligations and liabilities of taking care of sisters or have young siblings to look after should also be accorded preference.
2. Young Orphans / Handicapped persons, especially females who have nowhere to go are to be given due positive consideration.
3. The income of the family and the conditions in which they are living should also be of paramount importance.
4. Old cases except those where the conditions of the family are penurious and have earlier also been considered but not recommended may not be recommended since things would have been stabilized by now and there is no great urgency involved as compared to the cases where the family has suddenly been left destitute.
5. Pursuant to Govt. of India OM No. 14014/19/2002-Estt(D) dated 5.5.2003 the already rejected cases may be reconsidered and those again rejected for third time may not be taken up in future.

The Committee after carefully scrutinizing all the 561 cases short listed the following applicants (including those applicants whose cases were earlier rejected) who can be considered for providing appointment on compassionate grounds subject to verification of details as submitted by the applicants. This verification is to be carried out by the concerned Deputy Commissioners. After verification these applicants will be given


These cases may now be sent to the respective Deputy. Commissioners / SDMs for verification of the claims as made in the applications.
