**MINUTES OF THE MEETING OF THE SCREENING COMMITTEE HELD
ON 13th AND 26th JULY 2005 TO CONSIDER CASES OF
APPOINTMENT ON COMPASSIONATE GROUNDS**

The Screening Committee for the purpose of considering cases for appointment on compassionate grounds was notified in September, 1997. The present composition of the Committee is as follows:-

A meeting of Screening Committee was convened on 13/07/2005 and 26/07/2005 in the Chamber of Pr. Secretary (Urban Development) to consider the cases for providing appointments on compassionate grounds based on the guidelines issued vide Govt. of India's Scheme for compassionate appointment 1998 circulated vide DOPT OM No. F.14014/6/94-Esst. (D), dated 9.10.1998 and various judgements of the Hon'ble Supreme Court on the subject as referred to in the Scheme.

The Govt. of India has vide DOPT OM No. 14014/6/95/Estt.(D), dated 26.9.1995 restricted appointment on compassionate grounds upto a maximum of 5% of the vacancies available for the direct recruitment quota in any Group 'C' or 'D' post.

The Govt. of India vide DOPT OM No.14014/19/2002-Esst.(D), dated 5.5.2003 provides that the Committee may review genuine and deserving cases, rejected earlier due to non-availability of regular vacancies. The maximum time a person's name can be kept under consideration for offering compassionate appointment will be three years subject to the condition that the prescribed Committee has reviewed and certified the penurious condition of the applicant at the end of the first and the second year.

Besides above, it has been decided by the Government to adhere to the following criteria while considering the cases for appointment on compassionate grounds:-

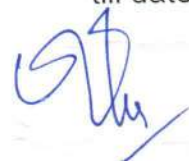
1. The first priority would be for families, which are living in extremely indigent circumstances and having all children who are less than 12 years of age and no other source of livelihood e.g. rent, ownership of house, land, belonging of relative values etc.
2. Next consideration can be given to cases where the family is in extremely indigent circumstances and has minor children less than 18 years of age and no other source of employment.

In the meeting held on 13th & 26th July, 2005 the following were present: -

The complete details of all the applicants viz. pension being received, terminal benefits, property, if any, liabilities, earning members etc. were placed before the Screening Committee in a tabular form to enable the members to have a comprehensive look of the cases. The details of the vacancies were also placed before the Screening Committee.

Since the vacancies available for the compassionate quota are limited, only the most deserving and needy candidates have to be short listed. Accordingly, the Committee, taking a holistic and pragmatic approach, was of the unanimous decision to adhere to the following: -

1. Young widows with young children living in indigent circumstances deserve far greater consideration as compared to families where there is already an earning member or male member who is on the threshold of being able to becoming self employed. Of these, widows having young daughters deserve far greater sympathy. Similarly, the applicants who have obligations and liabilities of taking care of sisters or have young siblings to look after should also be accorded preference.
2. Young Orphans, especially females living in indigent circumstances are to be given due positive consideration.
3. Old cases which have earlier also been considered but not recommended, may not be recommended unless the conditions of the family is penurious in relation to others or some new facts have been brought to the notice of the Committee.

Lengthy deliberations were held between the members. Each case was discussed in detail. Keeping in view the aforementioned criteria and the constraint of vacancies the Committee short listed 99 applicants who are to be provided compassionate appointment subject to the verification of particulars submitted by the applicants. Such verifications are done by the concerned Deputy Commissioners. After the verification these applicants shall be given appointments on compassionate grounds.

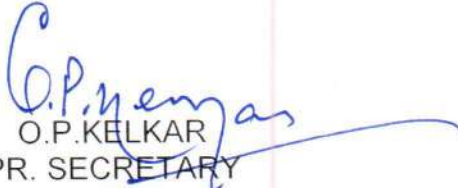
