2. Job Description:

The National Gallery of Modern Art, a unique institution that represents the evolution and transformation of pictorial arts in India during the last century is a sub- ordinate office under the Ministry of Culture. The incumbent will head the 3 wings of National Gallery of Modern Art situated at Delhi, Mumbai and Bengaluru and will be overall in-charge of its functioning. He will work for effective coordination and interaction with the Ministry of Culture, NITI Ayog, Advisory Committees, Art Acquisition Committee etc. and will be responsible for the overall management of the 3 wings of NGMA.
