**MINUTES OF THE MEETING OF THE SCREENING COMMITTEE
FOR APPOINTMENT ON COMPASSIONATE APPOINTMENT HELD
ON 21th SEPTEMBER, 2023, TO CONSIDER/RE-CONSIDER THE
CASES FOR APPOINTMENT ON COMPASSIONATE GROUNDS.**

1. A meeting of the Screening Committee for Appointment on Compassionate Grounds was convened on 21/09/2023 at 3:00 P.M., in the Chamber of Secretary (Vigilance){Link Officer of Pr. Secretary (Personnel)}. The meeting was attended by the following officers :-

The Director, UTCS, could not attend the meeting due to pre-occupancy.

2. The following issues, as per the agenda, were discussed in the meeting: -

- (i) Hon'ble CIC has issued directions to look into the matter of granting appointment to **Sh. Rakesh Kumar** s/o Lt. Sh.

Soraj Singh, Ex-Labour in Forest & Wild Life Department on compassionate ground as the Appellant is in miserable condition and it dire need of the employment, within the exiting guidelines of the Respondent Authority and to resolve the above said issue in a time bound manner, thus adhering to the law of natural justice.

- (ii) The case of **Smt. Rukhsana Begum** whose name was recommended by the screening committee it its meeting held in 2017 for the post of Nursing Orderly but now she has shown her inability to do the govt. job due to her poor health conditions.
- (iii) The case of **Sh. Rajan Gautam & Sh. Naveen Yadav** whose name were recommended by the screening committee it its meeting held in 2017 for the post of Warder in Central Jail. Nomination letters were issued. Both the applicants have not responded the offer of appointment/reminders issued by the Central Jail Authorities. Now the Central Jail Authorities has withdrawn the offer of appointment and referred both the cases to Services Department for further necessary action.
- (iv) To review the recommendation in case of **Sh. Yashpal** who was nominated for the post of Warder in the Central Jail, whose name was recommended by the screening committee it its meeting held in 2017. His nomination letter was

issued. It was reported by the Central Jail Authority that he failed to qualify the Physical Endurance Test required for the post of Warder. His case was returned by the Central Jail, Govt. of NCT of Delhi for further action.

- (v) To Review the recommendation in case of **Smt. Santosh Sharma**, Gr.III (Steno). Her name was recommended by the Screening Committee in its meeting held in the year 2013 for the post of Steno. Now it has been reported that she could not qualify the requisite steno test required for the post.
- (vi) To Review the case of **Smt. Sonal M. Dekate**. The post of Matron in Central Jail was recommended for the applicant. Accordingly nomination letter was issued. She requested to change her post. The Screening Committee review her request and recommended her case for the post of Non-Peon in Dte. Of health Services. Now she has requested to consider the name of her son for the appointment on compassionate grounds. Her representation has been forwarded to TTE department i.e. administrative department of deceased govt. servant to complete her case as per contents of this office O.M. dated 21.03.2023.
- (vii) To consider the case of **Smt. Karishma Singh** w/o Lt. Sh. Tej Pal Singh, TGT, Dte. of Education where the Directions

from Hon'ble PGC has been received for re-considering the case.

(viii) To review the case of **Sh. Avdhesh Pratap Singh** whose name was recommended by the screening committee in its meeting held in 2017 for the post of Warder but as per verification report received from revenue authority he is not found residing at the given address.

3. To consider/re-consider following 259 cases for appointment on compassionate grounds received from various departments of Govt. of NCT of Delhi as per following list:-

6. The Screening Committee was apprised that the appointment on compassionate grounds is governed by the DoPT, Govt. of India guidelines as contained in the Scheme for Compassionate Appointment and its amendments concluded in the Master Circular issued by DoPT vide OM dated 02.08.2022 on compassionate appointment including various judgments of the Hon'ble Supreme Court on the subject as referred in the Scheme.

7. The Committee was also informed that the very objective of the Scheme for Compassionate appointment is to grant appointment to a dependent family member of the Government servant dying in harness or who is retired on medical grounds, thereby leaving his family in penury and without means of livelihood, to relieve the family of the government servant from financial destitution and to help it to get over the emergency.



8. It was also informed that Govt. of India vide DOPT OM No. 14014/6/95/Estt.(D) dated 26/09/1995 restricted appointment on compassionate grounds up to a maximum of 5% of the vacancies available for the direct recruitment quota in any Group 'C' or 'D' post.

9. There is no provision of reservation for SC/ST/OBC in the cases of appointment on Compassionate Grounds. However, as per OM No. 14014/6/95-Estt (D) dated 26/09/1995 issued by DoPT, Government of India, a person selected for appointment on Compassionate Grounds should be adjusted in the recruitment roster against the appropriate category viz SC/ST/OBC/General category depending upon the category to which he belongs.

10. The Committee was also apprised that on the basis of the guidelines of the DoP&T, Govt. of India, and the criterion being followed for appointment on compassionate grounds and with the approval of Hon'ble Lt. Governor, Delhi, the Govt. of NCT of Delhi, has adopted a system of allocation of merit points to various attributes and parameters based on a maximum of 100 points-scales vide Services Department's Office Memorandum dated 21.03.2023 of Services Department.

10(i). The various attributes/ parameters are, 1) Status of the Applicant 2) Family Pension, 3) Terminal benefits, 4) Monthly income of the family from all sources, 5) Details of immovable property/properties,

6) Dependents of the Deceased /retired on medical grounds Government Servant, 7) No. of unmarried/divorcee daughter, 8) No. Of Minor children, 9) remaining service and 10) applicant being physically handicapped/ disabled dependent daughter/ if the deceased had received Gallantry or Presidential awards earlier/dependent (s) of deceased government servant (spouse and children only) if suffering from critical illness namely Cancer, Kidney failure, Coma etc.

11. The complete details of all the applicants viz. status of the applicant, pension being received, terminal benefits, property (if any), liabilities, earning members, educational qualification, merit points of each candidate for various attributes were placed before the Screening Committee to enable the members to have a comprehensive look of all these cases. The details of the vacancies were also placed before the Screening Committee.

12. The Screening Committee was also apprised with the proceedings held in the Screening Committee which was held on 08.08.2023. The Screening Committee was intimated that all the directions issued by the Screening Committee in its meeting 08.08.2023 have been complied with and the result shall be uploaded on the Website of the Services Department for information to the General Public.

13. The Committee discussed the provisions of the Scheme, various circulars of Services Department, the point based system adopted

by the Government of NCT of Delhi and relevant instructions, clarifications issued by the DoP&T, Govt. of India, from time to time.

14. After considering the facts of each case and in view of the guidelines, policy and the vacancies available for appointment on compassionate grounds, the observations/recommendations of the Screening Committee are as under:

14(i). With regard to the case of **Sh. Rakesh Kumar** s/o Lt. Sh. Soraj Singh, Ex-Labour in Forest & Wild Life Department wherein direction have been received from Hon'ble CIC, the Screening Committee was apprised that the death of Sh. Soraj Singh occurred in the year 2006.

His case was placed before the Screening Committee in the meetings held in 2012 & 2013 but was not recommended. On the directions of the Hon'ble CAT, the case was third time placed before the Screening Committee meeting held in the year 2017, it was recommended to the post of Peon.

However, due to variation in the fact submitted by him and verification report of Revenue Authority, the Screening Committee withdrew its earlier recommendation and rejected the case on finding in his misrepresented case, in its meeting held on 13.10.2020.

On the directions of Hon'ble CIC, the administrative department of Sh. Rakesh Kumar was requested to re-submit the case vide this office letter dated 29.03.2023 which is still awaited.

Further, the Screening Committee was apprised that in response of the reference of Hon'ble CIC dated 21/07/2023, the Services Department vide its letter dated 11.08.2023 has placed all facts related to the case of Sh. Rakesh Kumar before the Hon'ble CIC. The Hon'ble CIC was also intimated that the case of Sh. Rakesh Kumar shall be placed before the Screening Committee and the decision of the Screening Committee shall be communicated to Sh. Rakesh Kumar and Hon'ble CIC in due course.

After going through all the facts of the case, **the Screening Committee decided to reject the case of Sh. Rakesh Kumar S/o Lt. Sh. Soraj Singh as it has already been considered three time but not recommended on all occasions. Moreover, the death of the Govt. Servant had occurred long back in the year 2006.**

14(ii) With regard to the case of **Smt. Rukhsana Begum**, after considering the request of Smt. Rukhsana Begum wherein she has requested to cancel her job as she is not in the state to do the job, duly forwarded by the Directorate of Education, i.e. the Admn. Department whose name was recommended for the post of Nursing Orderly by the Screening Committee in its meeting held in 2017. **Accordingly, on going through the record and request of Smt. Rukhsana Begum, the Screening Committee decided to**

withdrew its earlier recommendation given in its meeting held in 2017 in r/o Smt. Rukssana Begum.

14(iii). With regard to the cases of **Sh. Rajan Gautam & Sh. Naveen Yadav**, the Screening Committee was apprised that the name of both these candidates was recommended for the post of Warder in the Central Jail.

Accordingly, nomination letters were issued to the Central Jail and to both these candidates. The Central Jail Authority has reported that both these candidates have not responded to the offer of appointment and subsequent reminders issued to both these candidates at their given addresses.

Now, the Central Jail Authority has withdrawn the offers of appointment issued to both these candidates.

In view of the same and on going through all the record, the Screening Committee decided to withdrew its earlier recommendation given in its meeting held in 2017 in r/o both of the candidates i.e. Sh. Rajan Gautam and Sh. Naveen Yadav and directed to inform the concerned administrative departments accordingly.

14(iv). With regard to the case of **Sh. Yashpal** whose name was recommended for the post of Warder in the Central Jail by the Screening Committee in its meeting held in the year 2017.

Accordingly, nomination letter was issued to the Central Jail Authority and to the candidate. The Central Jail Authorities informed that Sh. Yashpal failed to qualify the Physical Endurance Test required for the post of Warder. The Screening Committee was also apprised that earlier in such type of cases, the candidate(s) was offered another lower post i.e. Nursing Orderly.

On going through all the record and the previous practice, the Screening Committee decided to recommend the name of Sh. Yashpal for the post of Nursing Orderly which has arisen due to refusal of Smt. Rukhsana Begum and still lying vacant in the department.

14(v). With regard to the case of **Smt. Santosh Sharma**, Gr.III (Steno), whose name was recommended for the post of Steno in the Screening Committee meeting held in the year 2013. Smt. Santosh Sharma joined the Directorate of Education after being nominated by the Services Department on the recommendations of the Screening Committee in the year 2013.

After considering the report of the Administrative Department wherein it has been stated that Smt. Santosh Sharma could not qualify the proficiency test i.e. Steno Test required for the post. **Accordingly, on going through all the record and the previous practice, the Screening Committee decided to revert Smt. Santosh Sharma to the post of Jr. Asstt. Which shall be adjusted from the latest available vacancy of Jr. Assistant**

provided by the Services Department. Orders in this regard may be issued by Services-III Branch, Services Department accordingly.

14(vi). With regard to the case of **Smt. Sonal M. Dekate**, the Screening Committee was apprised that a post of Matron in Central Jail was recommended for the applicant by the Screening Committee in its meeting held in the year 2017.

Accordingly nomination letter was issued to the Department and the applicant. Smt. Sonal M. Dekate requested to change her post. In the Screening Committee meeting held in the year 2021, the Screening Committee reviewed her request and recommended her name for the post of Non-Peon in Dte. Of Health Services.

The nomination letter was also issued to the Administrative Department and the applicant. Now she has requested to consider the name of her son for the appointment on compassionate grounds in her place.

Her representation has already been forwarded to TTE department i.e. administrative department of deceased govt. servant, to examine the case as per contents of this office O.M. dated 21.03.2023. The Screening Committee after examine the para 15 of the Master Circular on Scheme of Compassionate Appointment dated 02/08/2022 issued by DoPT, Govt. of India which reproduced as under :-

"15 REQUEST FOR CHANGE IN POST/PERSON

When a person has been appointed on compassionate grounds to a particular post, the set of circumstances, which led to such appointment, should be deemed to have ceased to exist. Therefore,--

(a) he/she should strive in his/her career like his/her colleagues for future advancement and any request for appointment to any higher post on consideration of compassion should invariably be rejected.

(b) an appointment made on compassionate grounds cannot be transferred to any other person and any request for the same on considerations of compassion should invariably be rejected."

On going through all the record and instructions contained in the above referred OM, the Screening Committee decided to reject the request of Smt. Sonal M. Dekate, for change of candidature to her son from herself.

14(vii) With regard to the case of **Smt. Karishma Singh** w/o Lt. Sh. Tej Pal Singh, the Screening Committee was apprised that Hon'ble PGC, Delhi has issued directions to reconsider her case to the Services Department and the Directorate of Education has also been directed to complete the case of appointment on Compassionate Grounds and submit the same to the Services Department.

The concerned office where the deceased government servant working last, Directorate of Education, Govt. of NCT of Delhi vide

reminder Ref. No. G-Co-ED.SSS/Sec-3/23/1233-1237 dated 13/09/2023 (placed on record) has informed that the applicant has been requested (4th time) to submit requisite documents. The case is still pending with the Administrative Department. **On going through all the record, the Screening Committee decided and directed to place the case of Smt. Karishma Singh w/o Lt Sh. Tej Pal Singh, in the Screening Committee meeting once it is received.**

viii. With regard to the case of **Sh. Avdhesh Pratap Singh** whose name was recommended for the post of Warder in the Screening Committee held in the year 2017. As per practice, the case was referred to the Revenue Authority for seeking Verification Report.

The concerned district Revenue Authority has intimated that Sh. Avdhesh Pratap Singh is not found residing at the given address. **On going through all the record and keeping in view the report of the District Revenue Authority, the Screening Committee decided to withdraw its earlier recommendations given in the meeting of 2017 in the case of Sh. Avdhesh Pratap Singh and directed to inform the concerned administrative departments of deceased government servant accordingly.**

14(ix). A list of 244 cases for consideration/reconsideration containing inter-alia merit points awarded to these 244 candidates (259-15= 244) as per Policy adopted by this government, as referred in the following para, were placed before the Screening Committee for consideration and recommendation thereof

14(x). On going through all the records in r/o these 259 cases for appointment on Compassionate Grounds keeping in view the instructions contained in the Master Circular on Compassionate Appointment of DoPT, Govt. of India alongwith the existing policy of this Government, the Screening Committee decided to **REJECT** the following 15 cases without going into the merit as these cases were not found fit as per remarks recorded against each case :-

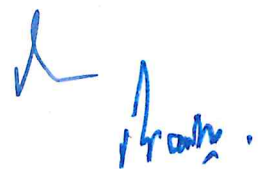
15. The screening Committee was apprised that as per point "j" of the OM dated 21/03/2023 issued by the Services Department, the cut of date for awarding merit points for various attributes is taken as 01/01/2023 in r/o all the 259 cases.

16. The Committee observed that now there are only **103** vacancies available of different categories under Group "C" and Erstwhile Group "D" posts as on 20/09/2023 to be considered for the remaining 244 cases of appointment on compassionate grounds.

17. Accordingly, the Screening Committee decided **to short-list 103 candidates out of following 244 applicants for appointment on compassionate grounds on the basis of the merit points which have calculated by the officials and officers of the compassionate branch of Services Department on the basis of**







the information provided by the applicant/Administrative Department and as per instructions contained in the OM dated 21/03/2023 issued by the Services Department :-
