*Knowledge repository for the future ready bureaucracy of Amrit Kaal*

#### Description

To ensure the creation of shared learning resources in the capacity building ecosystem of India, the Capacity Building Commission has undertaken an initiative for the creation of a **Knowledge Bank (Amrit Gyaan Kosh)** which will be a repository of case studies, and teachable/ learning resources (in print, audio and electronic media format).

Following the Hon'ble Prime Minister's call of Atma Nirbharta, these resources will be best practices about India, exemplar cases, and scalable models which will guide, motivate and empower group A, B and C officials (across the Government of India, States, Municipalities and Panchayats) to perform optimally in their workplaces. These cases will be written by faculty members of the civil services training institutes, and their capacities will be built to both draft and teach these cases for training purposes. Upon request, Institutes across the globe will also be allowed to collaborate and use the resources of Amrit Gyaan Kosh.

The Knowledge bank will have India-specific content in the following format:

- Caselets with learning resources (available in English, Hindi and Braille)
- Teaching Notes
- Video Snippets
- Infographics
- Resources from different ministries/ states and PSUs

The above resources will be readily available on an exclusive portal for Amrit Gyaan Kosh which will be embedded in the websites of iGOT and CBC.

The resources are based on the following principles:

- **Relevant:** current and contemporary (i.e. not older than three years).
- **Relatable:** For the learner to relate the learning to his/her day-to-day life.
- **Applicable:** For the learner to apply these learnings.
- **Scalable:** The solution presented in the case should be a scalable model across geographies and institutions.

Currently, Amrit Gyaan Kosh has partnered with 13 Central and State training institutes and five external institutes to author/edit the case studies. The five external institutes are:

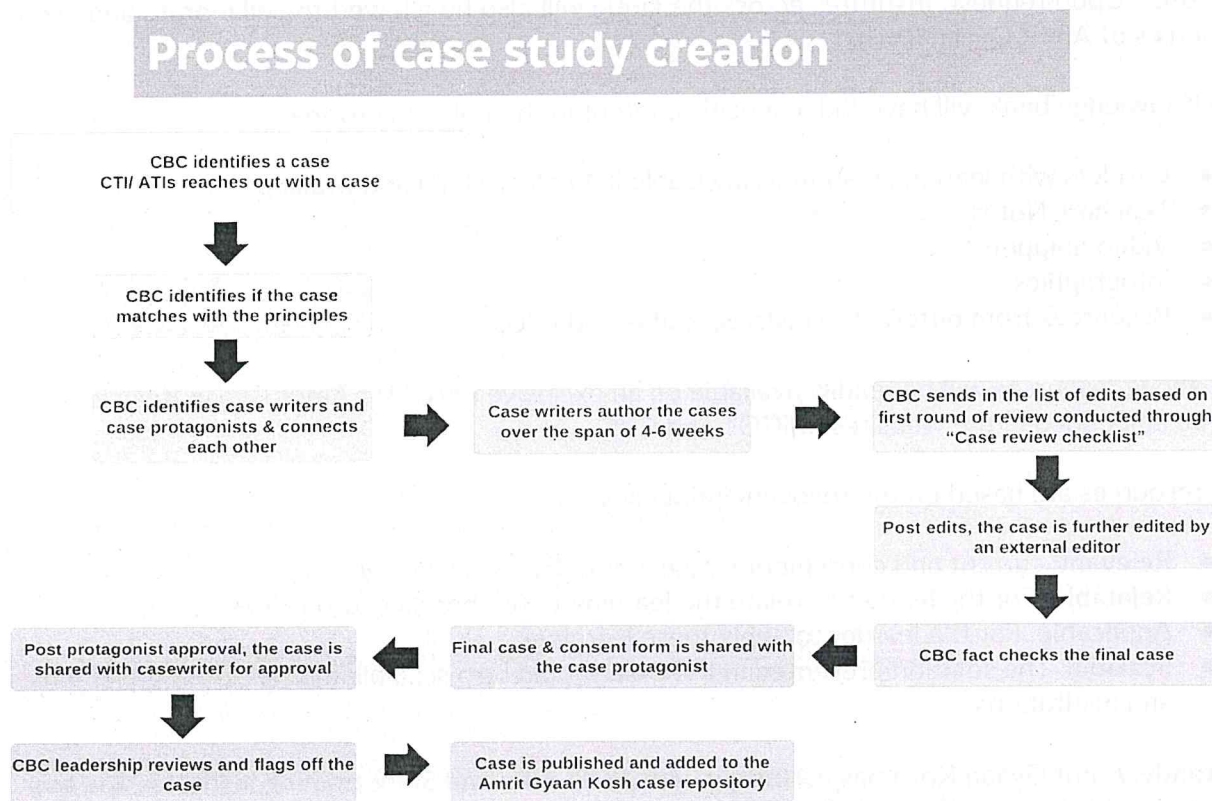
1. Indian School of Public Policy

### Intended outcome

1. Enable shared learning resources
2. A one-stop repository of **India-centric case studies and success stories.**
3. Motivation and incentivisation of officials to **become case examples** for others.
4. Novel and relatable learning content for the training ecosystem of civil services (such as ATIs and CTIs)
5. Engagement of Knowledge Partners of the CBC
6. Coverage of novel initiatives such as the **COVID-19 Vaccination plan, Ayushman Bharat, Chandrayaan-3, and Mission Youth, DBT, PM PVTG** among other similar success stories of India.

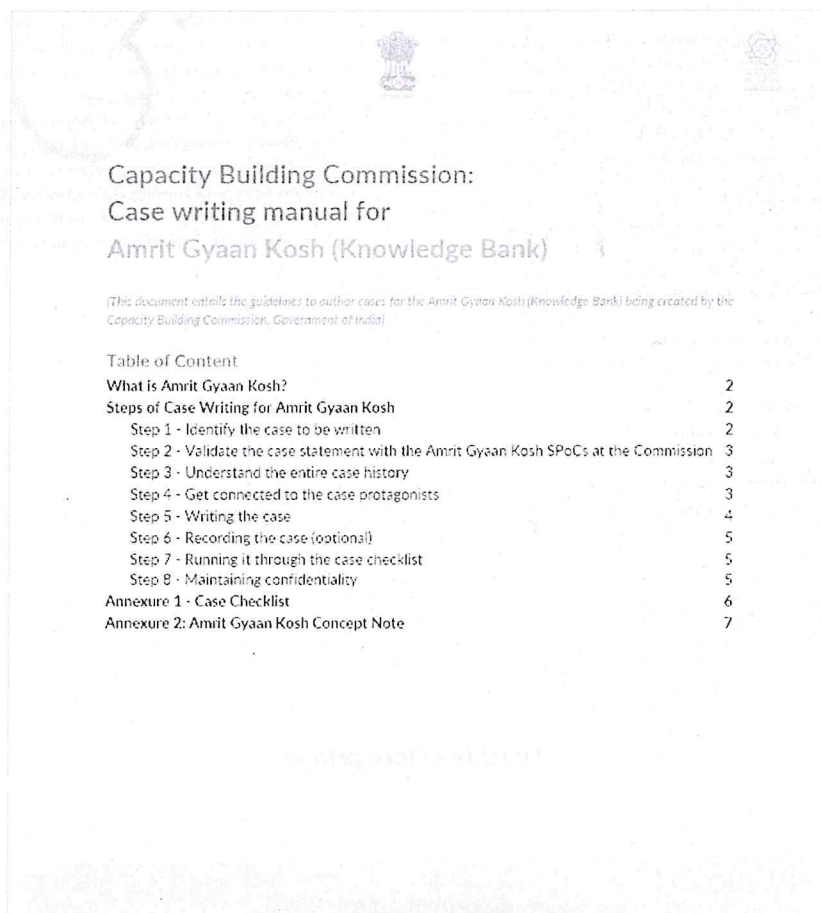


### Current Status

3. Pan-India coverage of states, around 11 states such as Uttar Pradesh, Jammu & Kashmir, Meghalaya, Kerala, Uttarakhand, Tamil Nadu, Maharashtra, Delhi, Madhya Pradesh, Arunachal Pradesh, Punjab etc.

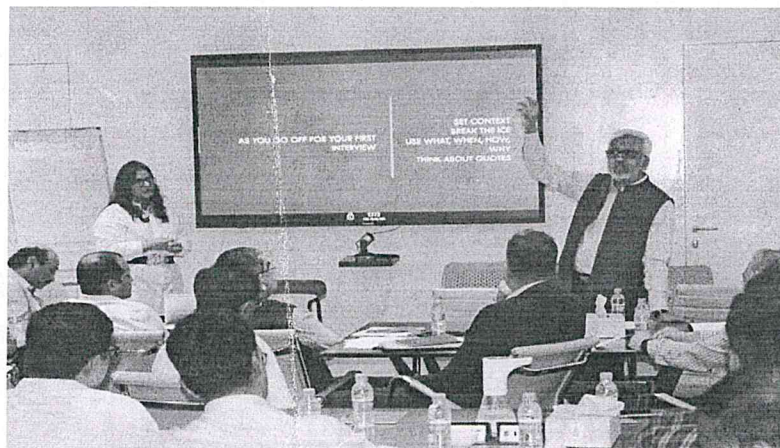
