The concerned Head of Departments are requested to issue formal orders for grant of Non Functional Selection Grade in respect of officials working in their departments, complying Dopt OM No.20/49/2009-CS-II(B) dated 22.06.2011 of Govt. of India, Ministry of Personnel, Public Grievances & Pension (Department of Personnel & Training) and Order No.58 dated 03.02.2015 of Services Department. However before the issuance of the formal orders the Head of Departments may again confirm that these officials are clear from vigilance angle.

The officials concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the order granting the Non Functional Selection Grade

The officials who are on deputation will get Non Functional Selection Grade from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government
