Non Functional Selection Grade to above mentioned Gr.III (Steno) has been allowed on the basis of eligibility list provided by Cadre Controlling Authority i.e. Services-III Department in respect of Gr.III (Steno). It is subject to the condition that, in future, due to addition or deletion of names in the eligibility list, if there is a change in the date of eligibility in respect of above concerned Gr.III (Steno), they will have no claim over the date of eligibility. HODs are requested to obtain an Undertaking from the concerned official to this effect.

The officials concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the order granting the Non Functional Selection Grade.

Further, Non Functional Selection Grade is subject to the undertaking that in the event of over payment, which may be detected at later stage, the same will be recovered from their pay.

The concerned Head of Departments are requested to issue formal orders for grant of Non-Functional Selection Grade in respect of officials working in their departments, complying DoPT OM no. 20/49/2009-CS-II(B) dated 22.06.2011 of Govt. of India, Ministry of Personnel, Public Grievances & Pension (Department of Personnel & Training), and order no. 58 dated 03.02.2015 of Services Department. However, before the issuance of the formal orders the Head of Departments may again confirm that these officials are clear from vigilance angle.
