**ORDER No. 125**

On the recommendations of the Internal Committee constituted for grant of Non Functional Selection Grade to Grade-III(DASS)/Senior Assistants vide OM No.F.3(5)(1)/NFSG/ S.III/2015/987-992 dated 29.04.2015 in accordance with the instructions contained in DoPT, Govt. of India O.M No.20/49/2009-CS-II(B) dated 22.06.2011, the Competent Authority is pleased to grant Non Functional Selection Grade(NFSG) to Smt. Shanti Sharma, Grade-III(DASS) /Senior Assistants in the Level- 6 of pay matrix table under 7<sup>th</sup> CPC i.e. Rs. 35,400-1,12,400/-(Pre-revised Pay Scale of Rs. 9300-34800 in PB - II with Grade Pay of Rs.4200/-) w.e.f. the date mentioned against her name:

Non-Functional Selection Grade to above mentioned Grade-III(DASS)/ Senior Assistant has been granted on the basis of Eligibility list provided by Cadre Controlling Authority i.e. Services-II Department, Govt. of NCT of Delhi. The grant of NFSG benefits is subject to the condition that if there is a change in the date of eligibility list in respect of above-mentioned Grade-III(DASS)/Senior Assistant in future, due to addition or deletion of name in the eligibility list, the official will have no claim over the date of eligibility. The Head of Department is requested to obtain an Undertaking from the concerned official to this effect.

The official concerned may be allowed to exercise her options, if any, under FR 22 within one month of the issuance of the order granting the Non Functional Selection Grade (NFSG).

Further, grant of Non Functional Selection Grade is subject to the undertaking that in the event of over payment, which may be detected at later stage, the same will be recovered from her pay.

The concerned Head of Department is requested to issue formal order for grant of Non-Functional Selection Grade in respect of the official in pursuance to DoPT OM no. 20/49/2009-CS-II(B) dated 22.06.2011 of Govt. of India, Ministry of Personnel, Public Grievances & Pension (Department of Personnel & Training), and order no. 58 dated 03.02.2015 of Services Department, Govt. of NCT of Delhi. However, before the issuance of the formal order the Head of Department may again confirm that the official is clear from vigilance angle.
