On the recommendations of the Screening Committee constituted for grant of financial upgradation under the Assured Career Progression Scheme (ACP) to the then Grade-IV (DASS) Officials re-deployed from DEDA/DSMDC in accordance with the instructions contained in DoPT, Govt. of India O.M NO. 35034/1/97-Estt.(D) dated 09/08/1999, Circular dated 29.07.15 regarding counting of past service rendered at DEDA/DSMDC & the policy decision of the Department circulated vide letter dated 03.06.19, the Secretary (Services) is pleased to grant 2nd financial upgradation under ACP Scheme to following Official re-deployed from DEDA/DSMDC with pay protection in pursuance of point of clarification no. 40 of DoPT, GOI, OM No. 35034/97/Estt.(D)Vol.IV dated 18.07.2001 and policy decision of Services Departments circulated vide letter dated 03.06.19 from the existing pay scale i.e. Rs. 4500-7000/- (S-8) to Rs 5000-8000/- (S-9) w.e.f. the date mentioned against his name:

The Official concerned may be allowed to exercise his options, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Assured Career Progression Scheme. However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The concerned Head of Department are requested to issue formal orders for grant of the 2nd financial upgradation in respect of the above-mentioned Officials. However, before the issuance of the formal orders the Heads of Departments may again confirm that the official has completed 24 years of regular service with only one promotion / financial upgradation and are clear from Vigilance angle. Ad-hoc / temporary service period shall not be counted for grant of ACP benefits.
