The Official concerned may be allowed to exercise his options, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Assured Career Progression Scheme. However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The concerned Head of Department are requested to issue formal orders for grant of the financial upgradation in respect of the above-mentioned Officials. However, before the issuance of the formal orders the Heads of Departments may again confirm that the official has completed 24 years of regular service with only one promotion / financial upgradation and are clear from Vigilance angle. Ad-hoc / temporary service period shall not be counted for grant of ACP benefits.
