On the recommendations of the Screening Committee constituted for grant of financial upgradation under the Assured Career Progression Scheme to the Grade IV(DASS) re-deployed in GNCT of Delhi from DEDA/DSMDC in accordance with the instructions contained in OM No. 35034/1/97-Estt.(D) dated 09.08.99 issued by Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training) of govt. of India and policy circular dated 29.07.2015 regarding counting of past service for benefits for ACP/MACP schemes to the officials rendered services at DEDA/DSMDC and policy circulated dated 03.06.19 for ACP benefits to official redeployed from DEDA/DSMDC, Pr. Secretary (Services) is pleased to grant 2nd financial upgradation under ACP benefits to the following officer on completion of 24 years of regular service after including past regular services rendered at DEDA/DSMDC from the existing pay scale of Rs. 4000-100-6000 (revised to 5200-20200+2400 GP in 6th CPC) to immediately next higher pay scale in the hierarchy of pay Rs. 4500-125-7000 (revised to 5200-20200+GP 2800 in 6th CPC) after completion of 24 years for regular service in same pay scale w.e.f. the date mentioned against his name:-

The grant of ACP is further subject to the condition that:

- 1) The Official concerned may be allowed to exercise his options, if any, under FR 22 within one month of the issuance of the Order granting the financial upgradation under the Assured Career Progression Scheme.
- 2) The grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

- 3) It should be ensured by concerned Head of Department that the above-mentioned Official is absolutely clear from vigilance angle at all levels at the time of eligibility.
- 4) The concerned Head of Department is requested to issue formal order for grant of the 2nd financial upgradation under ACP Scheme in respect of the above-mentioned Official after verifying and checking the service particulars with regard to date of appointment etc as mentioned above are correct and also after ensuring that all the conditions prescribed above have been fulfilled and complied with. Discrepancy, if any be brought to notice of this Department and the orders in respect of such Official(s) may not be implemented till clarification from this Department. Adhoc/temporary service period shall not be counted for grant of ACP benefits.
