On the recommendations of the Screening Committee constituted for grant of 3rd financial upgradation under the Modified Assured Career Progression Scheme to Grade I (DASS) in accordance with the instructions contained in OM No. 35034/3/2008-Estt.(D) dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. Of Personnel & Training) and the policy decision taken by the Department circulated vide letter dated 03.06.19, the Pr. Secretary (Services) is pleased to grant 3rd MACP benefits to the following officer on completion of 30 years of regular service after including past regular services rendered at DEDA/DSMDC etc. in terms of circular dated 29.07.15 from existing pay of Rs.9300-34800 with Grade Pay Rs. 5400 in PB-2 to immediate next higher Grade Pay in the hierarchy of the recommended revised pay band and Grade Pay Rs. 5400 in PB-3 w.e.f. the date mentioned against his name :-

The grant of MACP is further subject to the condition that:-

- 1) The Officer concerned may be allowed to exercise his options, if any, under FR 22 within one month of the issuance of the Order granting the financial upgradation under the Modified Assured Career Progression Scheme.
- 2) The grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage, the same will be recovered from his pay.
- 3) The Officer who is on deputation will get financial upgradation from the dates shown against his names only on notional basis, however, he will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of his repatriation to Delhi Government.
- 4) The concerned Head of Departments are requested to ensure before issuance of formal order for grant of 3rd financial up-gradation under MACP Scheme that the Officer concerned has not refused regular promotion before becoming entitled to a financial upgradation in accordance with provisions contained in Para 25 of Annexure - I of DoPT, Govt. of India O.M Dated 19.05.2009 and Para-24 of Annexure-I of O.M dated 22.10.2019.
- 5) It should be re-ensured by concerned Head of Departments that the above-mentioned Officer is absolutely clear from vigilance angle at all levels at the time of eligibility.

- 6) The concerned Head of Department is requested to issue formal order for grant of the 3rd financial upgradation under MACP Scheme in respect of the above-mentioned Officer after verifying and checking the service particulars with regard to date of appointment etc. as mentioned above are correct and also after ensuring that all the conditions prescribed above have been fulfilled and complied with. Discrepancy, if any be brought to notice of this Department and the order in respect of such Official (s) may not be implemented till clarification from this Department.
