The grant of MACP is further subject to the condition that:-

- 1) The Officer concerned may be allowed to exercise his options, if any, under FR 22 within one month of the issuance of the Order granting the financial upgradation under the Modified Assured Career Progression Scheme.
- 2) The grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage, the same will be recovered from his pay.
- 3) The Officer who is on deputation will get financial upgradation from the dates shown against his names only on notional basis, however, he will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of his repatriation to Delhi Government.
- 4) The concerned Head of Departments are requested to ensure before issuance of formal order for grant of 3rd financial up-gradation under MACP Scheme that the Officer concerned has not refused regular promotion before becoming entitled to a financial upgradation in accordance with provisions contained in Para 25 of Annexure I of DoPT, Govt. of India O.M Dated 19.05.2009 and Para-24 of Annexure-I of O.M dated 22.10.2019.
