2. The grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage, the same will be recovered from his pay. Cont...

- 3. The Officials who is on deputation will get financial upgradation from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of his repatriation to Delhi Government.

The concerned Head of Departments are requested to ensure before issuance of formal order for grant of 3rd financial up-gradation under MACP Scheme that the Official concerned has not refused regular promotion before becoming entitled to a financial upgradation in accordance with provisions contained in Para 25 of Annexure - I of DoPT, Govt. of India O.M Dated 19.05.2009 and Para-24 of Annexure-I of O.M dated 22.10.2019.
- 5. It should be re-ensured by concerned Head of Departments that the above-mentioned Officials are absolutely clear from vigilance angle at all levels at the time of eligibility.
- 6. The concerned Head of Departments are requested to issue formal order for grant of the 3rd financial upgradation under MACP Scheme in respect of the above-mentioned Officials after verifying and checking the service particulars with regard to date of appointment etc. as mentioned above are correct and also after ensuring that all the conditions prescribed above have been fulfilled and complied with.
