These officials may exercise their option with regard to fixation of pay, if any, as per FR22 within one month from the issue of this order.

However, above named officials are not entitled to the payment of pay & allowances for the period for which they have not actually worked as Grade-II (DASS). The benefit of promotion will be admissible to the above mentioned officials only with effect from the actual date of joining to the post of Grade-II (DASS) in the Department in which they have been posted on promotion to the post of Grade-II (DASS) vide this order.

The promotion shall remain subject to outcome of SLP(C) No.30621/2011, SLP(C) No.6915/2014, SLP(C) No. 31288/2017 & connected SLPs pending before the Hon'ble Supreme Court in all the above cases except Sl. NO. 2 & 4.

**The Head of Department concerned should ensure that the aforesaid officials were clear from vigilance angle and no penalty was in operation on the date of his/her notional promotion mentioned against each and no penalty against the official is in operation before relieving above Grade-III (DASS) officials to assume their duties as Grade-II (DASS) as per the instructions contained in DoPT OM No. 22011/4/91-Estt.(A) dated 14/09/1992 and other related OMs.**

**If any of the officials out of the above, is not clear from vigilance angle or his integrity is not certified as on date of notional promotion/date of issuance of this order or has resigned/expired/taken VRS etc., the same should be brought to the notice of this department immediately.**

Consequent upon their promotion, the aforesaid officials are hereby transferred/posted against vacant posts of Assistant Section Officer/Grade-II (DASS) in the departments as mentioned against their names with immediate effect.
