The terms and conditions of the promotion of above mentioned officials shall be as under:-

- (i) The above officials shall be on probation for a period of two years.
- (ii) They shall be required to pass a test in typewriting at the speed of 30 w.p.m. in English or 25 w.p.m. in Hindi on manual typewriter OR at the speed of 35 w.p.m. in English or 30 w.p.m. in Hindi on computer (35 w.p.m. and 30 w.p.m. correspond to 10500 KDPH/ 9000 KDPH on an average of 5 key depressions for each word) during the period of probation to be conducted by Directorate of Training & Technical Education, Govt. of NCT of Delhi, during the period of Probation.
- (iii) Their services will be governed by the DASS Rules, 1967, as amended from time to time and any other administrative orders in-force.
- (iv) These officials may exercise their option with regard to fixation of pay, if any, as per FR 22 within one month from the date of promotion or appointment to the post of Grade-IV (DASS).
- (v) They shall not be granted any increment in the scale of Grade-IV (DASS) unless either they qualify the typewriting test at the prescribed speed or they are exempted from passing type test by the Competent Authority. However, the officials who have already attained the age of 45 years as on the date of promotion are hereby EXMPTED FROM PASSING THE TYPE TEST. Their services governed by the DASS Rules, 1967 as amended from time to time.
- (vi) All the HODs shall issue the formal orders of appointment to the post of Grade-IV (DASS) with the terms and conditions as stipulated in these orders. In case of failure of joining duties as Grade-IV (DASS), intimation must be furnished to this department. Further, the Head of Departments are also requested to verify the original matriculation or equivalent certificate and SC/ST/OBC certificate at the time of appointment.
- (vii) These officials shall have to appear in the typewriting test conducted by Directorate of Training & Technical Education from time to time and

quarterly progress report shall be sent to the Services Department by the concerned HoDs.

Consequent upon nomination for promotion to the post of Grade-IV(DASS), the following officials are hereby transferred/posted, with immediate effect, against the vacant posts as mentioned below:-
