- 1) No further financial upgradation under MACP would be admissible to these Officials.
- 2) The Official concerned may be allowed to exercise his options, if any, under FR 22 within one month of the issuance of the Order granting the financial upgradation under the Modified Assured Career Progression Scheme.
- 3) The grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.
- 4) Official who is on deputation will get financial upgradation from the dates shown against his names only on notional basis, however, he will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of his repatriation to Delhi Government.
