ORDER 49

Whereas the benefits of 3rd financial upgradation under MACP scheme was granted to Sh. Anil Kumar Saxena, Adhoc DANICS (Retired) vide this department order dated 05.11.2015 w.e.f. 01.09.2008.

And whereas, the administrative department of the Officer i.e Industries Department, Govt. of NCT of Delhi informed vide letter dated 15.05.2016 that Sh. Anil Kumar Saxena was charge-sheeted for major penalty under Rule 14 vide memo dated 11.01.2005 and as per order dated 26.08.2010 by the Hon'ble Lt. Governor, a penalty of compulsory retirement with immediate effect was imposed with further directions of 5% cut on his admissible compensation pension for two years.

And whereas, Para 18 of DoPT, GOI O.M No.35034/3/2008-Estt. (D) Dated 19/05/2009 provides that "*In the matter of disciplinary/ penalty proceedings, grant of benefit under the MACPS shall be subject to rules governing normal promotion. Such cases shall, therefore, be regulated under the provisions of the CCS (CCA) Rules, 1965 and instructions issued thereunder*".

Now, on recommendations of the Screening Committee which have been accepted by the Competent Authority, the benefits of 3rd financial upgradation under MACP scheme granted to Sh. Anil Kumar Saxena (DOB 01.09.1950), Adhoc DANICS/Retired w.e.f. 01.09.2008 vide this office order no. 20 issued vide No. F.9(5)/2003/ACP/Prom.Cell/1373-1386 dated 05.11.2015 stands withdrawn with retrospective effect. The Industries Department, GNCT of Delhi is directed to take further necessary action to recover the financial benefits, if any, released to Sh. Anil Kumar Saxena, Adhoc DANICS (Retired), under intimation to this office immediately.
