Services Department vide order No. 57 dated 03.02.2015, revised the pay structure of Grade II (DASS) and Stenographers in PB -2 Rs. 9300-34800 from grade pay Rs. 4200 to Rs. 4600 w.e.f 01.01.2006.

The Officials concerned may be allowed to exercise their, options if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The Head of Departments concerned is requested to ensure before issuing final order that 30 years regular service of the officials does not include the period of service rendered in State Government/Statutory Body / Autonomous Body/Public Sector Organization as the period of past service in these bodies is not to be counted for grant of financial upgradation under MACP Scheme (Point No. 10 of DoPT OM dated 19.05.09)

The concerned Head of Departments are requested to issue formal order for grant of the 3rd financial upgradation in respect of the above mentioned officials working in their Departments. However, before the issuance of the formal orders the Heads of Departments may again confirm that these officials have completed 30 years regular service with two promotions since the date of their initial appointment in the service and are **clear from Vigilance angle**.
