The grant of MACP is further subject to the condition that:

- 1) No further financial upgradation under MACP would be admissible to these officials.
- 2) The Official concern may be allowed to exercise their options, if any, under FR22 within one month of the issuance of the Order granting the financial upgradation under the Assured Career Progression Scheme.

- 5) The concerned Head of Department is requested to ensure before issuance of formal order for grant of 3rd financial upgradation under MACP Scheme that the official concerned has not refused regular promotion in accordance with provisions contained in Para 25 of Annexure-1 of DoPT, Govt. of India O.M. dated 19.05.2009 and Para 24 of Annexure-I of O.M. dated 22.10.2019.

6) The Concerned Head of Department is requested to issue formal order for grant of the 3rd financial upgradation under MACP Scheme in respect of the above mentioned official after verifying and checking the service particulars with regard to date of appointment etc, as mentioned above are correct and also after ensuring that all the conditions prescribed above have been fulfilled and complied with. Discrepancy, if any be brought to notice of this Department and the orders in respect of such Official may not be implemented till clarification from this Department. Further, it may also be ensured that the officials are clear form vigilance angle at all levels and are not under currency of penalty, on the due date as mentioned in this order.
