On the recommendations of the Screening Committee constituted for grant of financial upgradation under the Modified Assured Career Progression(MACP) Scheme to Grade-IV (DASS)/Jr. Assistant officials in accordance with the instructions contained in OM NO. 35034/3/2008-Estt.(D) dated 19.05.09 & 22.10.19 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Secretary (Services) is pleased to grant 3<sup>rd</sup> financial upgradation to the following Grade-IV (DASS)/Jr. Assistant officials, who were initially appointed as Group-D employees and granted two financial upgradation/promotion (including in-situ promotion) before 01.09.08, in the Grade Pay of Rs. 2400/(Revised Level-4 in pay matrix of 7<sup>th</sup> CPC)- in the hierarchy of the recommended revised pay bands in terms of Para 5 & Para 28C of Annexure-I of DoPT, Govt. of India O.M dated 19.05.2009, on completion of 30 years of regular service w.e.f. the date mentioned against their names:

The grant of MACP is further subject to the condition that:

- 1) No further financial upgradation under MACP would be admissible to these Officials.
- 2) The Official concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the Order granting the financial upgradation under the Modified Assured Career Progression Scheme.
- 3) The grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.
- 4) Officials who are on deputation will get financial upgradation from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government.
- 5) The concerned Head of Departments are requested to ensure before issuance of formal order for grant of 3<sup>rd</sup> financial upgradation under MACP Scheme that the Official concerned has not refused regular promotion before becoming entitled to a financial upgradation in accordance with provisions contained in Para 25 of Annexure - I of DoPT, Govt. of India O.M Dated 19.05.2009 and Para-24 of Annexure-I of O.M dated 22.10.2019.
