ORDER NO. 203

On the recommendation of the Screening Committee constituted for grant of financial upgradation under the Modified Assured Career Progression Scheme (MACP) in accordance with the instructions contained in OM NO. 35034/3/2008-Estt.(D) dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Department of Personnel & Training), the Secretary (Services) is pleased to grant 3<sup>rd</sup> financial upgradation under MACP Scheme to **Grade- I (DASS) / PS/Sr. PA Officers who were initially appointed as Steno Grade-III on completion of 30 years of regular service** from the corresponding Pay Band-2 of Rs. 9300-34800/- Grade Pay of Rs. 4800/- to the immediate next higher grade pay of Rs. 5400/- (Pay Band-2) (Level 8 to Level 9 of Pay Matrix table under 7<sup>th</sup> CPC) in the hierarchy of the recommended revised pay bands on completion of 30 years of regular service with two promotion/financial upgradation w.e.f. the date mentioned against their names:

The Officer concerned may be allowed to exercise the option, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The concerned Head of Department is requested to issue formal order for grant of the 3<sup>rd</sup> financial upgradation in respect of the above mentioned Officer working in the Department. However, before the issuance of the formal orders the Head of Department may again confirm that the Officer has completed 30 years regular service with two promotion/financial upgradation and is clear from Vigilance angle.

The Officer on deputation will get financial upgradation from the date shown against the name only on notional basis, however, he will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of the repatriation to Delhi Government.


