The grant of MACP is further subject to the condition that:

- 1) The Official concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the Order granting the financial upgradation under the Modified Assured Career Progression Scheme.
- 2) The grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

- 3) The Official who are on deputation will get financial upgradation from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government.
- 4) The concerned Head of Departments are requested to ensure before issuance of formal order for grant of 3<sup>rd</sup> financial upgradation under MACP Scheme that the Official concerned has not refused regular promotion before becoming entitled to a financial upgradation in accordance with provisions contained in Para 25 of Annexure I of DoPT, Govt. of India O.M Dated 19.05.2009 and Para-24 of Annexure-I of O.M dated 22.10.2019.
- 5) It should be re-ensured by concerned Head of Departments that the abovementioned Officials are absolutely clear from vigilance angle at all levels at the time of eligibility.
- 6) The concerned Head of Departments are requested to issue formal order for grant of the 3<sup>rd</sup> financial upgradation under MACP Scheme in respect of the abovementioned Official after verifying and checking the service particulars with regard to date of appointment etc as mentioned above are correct and also after ensuring that all the conditions prescribed above have been fulfilled and complied with. Discrepancy, if any be brought to notice of this Department and the orders in respect of such Official(s) may not be implemented till clarification from this Department.
