The grant of MACP is further subject to the condition that:

1) No further financial upgradation under MACP would be admissible to these Officials.

2) The Official concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the Order granting the financial upgradation under the Modified Assured Career Progression Scheme.

3) The grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

4) Officials who are on deputation will get financial upgradation from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government.

Further, it may be re-ensured that the Official is clear from vigilance angle at all levels and is not under the currency of penalty, at the time of eligibility.
