**ORDER NO. 29**

On the recommendations of the Screening Committee constituted for grant of financial up-gradation under the Assured Career Progression Scheme to Grade-IV (DASS)/Jr. Assistants officials in accordance with the instructions contained in O.M. No. 35034/1/97 Estt.(D) dated 9.8.99 of the Govt. Of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Pr. Secretary (Services) is pleased to grant 1<sup>st</sup> financial upgradation under ACP Scheme to the following then Grade-IV(DASS)/Jr. Assistant(Now Grade-II(DASS)) on completion of 12 years regular service from the existing pay scale of Rs.3050-4590/- (pre-revised) to the next higher pay scale of Rs.4000-6000/- (pre revised) in the hierarchy of DASS cadre w.e.f. the date mentioned against their name:-

The grant of ACP is further subject to the condition that:

- 1) The Officials concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the Order granting the financial upgradation under the Assured Career Progression Scheme.
- 2) The grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.
- 3) The concerned Head of Departments are requested to ensure before issuing final order that 12 years of regular service of the official does not include the period of past service rendered in Autonomous body/Statutory body/State Govt. as the period of past service in these bodies is not to be counted for grant of financial up-gradation under ACP Scheme. (Clarification No.43 of DoPT OM dated 18.7.2001)
- 4) Official who are on deputation will get financial upgradation from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government.
- 5) The concerned Head of Departments are requested to issue formal order for grant of the 1<sup>st</sup> financial upgradation under ACP Scheme in respect of the above-mentioned Official and also verify the service particulars with regard to date of appointment etc. as mentioned above are correct. Discrepancy, if any be brought to notice of this Department and the orders in respect of such Official(s) may not be implemented till clarification received from this Department. Further, it may be re-ensured that the Official is clear from vigilance angle at all levels and is not under the currency of penalty, at the time of eligibility .
