ORDER NO. 31

On the recommendations of the Screening Committee constituted for grant of financial upgradation under the Modified Assured Career Progression Scheme to Grade-III (DASS)/S.A officials in accordance with the instructions contained in OM NO. 35034/3/2008-Estt.(D) dated 19.05.09 & OM NO. 35034/3/2015-Estt.(D) dated 22.10.19 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Pr. Secretary (Services) is pleased to grant 2<sup>nd</sup> financial upgradation under MACP Scheme to the following then Grade-III (DASS)/S.A officials on completion of 20 years of regular service with one promotion/financial upgradation or 10 years of continuous service in the same Grade Pay, from existing pay scale of Rs. 5200-20200/- with Grade Pay 2400/-(Revised Level 4 in pay matrix of 7<sup>th</sup> CPC) to the immediate next higher Grade Pay of Rs. 2800/-(Revised Level 5 in pay matrix of 7<sup>th</sup> CPC)- in the hierarchy of the recommended revised pay bands w.e.f. the date mentioned against their names:



- The grant of MACP is further subject to the condition that:
- 1) The Officials concerned may be allowed to exercise his options, if any, under FR 22 within one month of the issuance of the Order granting the financial upgradation under the Modified Assured Career Progression Scheme.
  - 2) The grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.
  - 3) Officials who are on deputation will get financial upgradation from the date shown against his name only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government.
  - 4) The concerned Head of Departments is requested to ensure before issuance of formal order for grant of 2<sup>nd</sup> financial upgradation under MACP Scheme that the Official concerned has not refused regular promotion before becoming entitled to a financial upgradation in accordance with provisions contained in Para 25 of Annexure - I of DoPT, Govt. of India O.M Dated 19.05.2009 and Para-24 of Annexure-I of O.M dated 22.10.2019.
  - 5) The concerned Head of Department is requested to issue formal order for grant of the 2<sup>nd</sup> financial upgradation under MACP Scheme in respect of the above-mentioned Officials and also verify the service particulars with regard to date of appointment etc. as mentioned above are correct. Discrepancy, if any be brought to notice of this Department and the orders in respect of such Official(s) may not be implemented till clarification received from this Department. Further, it may be re-ensured that the Official is clear from vigilance angle at all levels and is not under the currency of penalty, at the time of eligibility .
