1. The Official concerned may be allowed to exercise his options, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Assured Career Progression Scheme. However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from his pay.

2. The official has been declared surplus and redeployed in Delhi Govt. from SD Ayurvedic College. Head of Department may ensure before issue of final orders that the Official has not been given any financial upgradation/promotion and has completed 12 years of regular service after counting of past services rendered at SD Ayurvedic College. Ad-hoc / temporary service period shall not be counted for grant of ACP benefits. Any financial upgradation granted to the official without counting of past service at SD Ayurvedic College shall stand modified accordingly.

3. The concerned Head of Department is requested to issue formal order for grant of the 1st financial upgradation in respect of the above mentioned official. However, before the issuance of the formal orders the Head of Department may again confirm that the official has completed 12 years regular service with no promotions or 12 years of continuous service in the same grade pay and further, it may be ensured that the Officer is clear from vigilance angle at the time of eligibility.
