However, the financial benefits will be admissible to the above mentioned officials with effect from the actual date of joining to the post of Grade-II(DSS)/ASO and no arrear will be allowed for the period he/she has not actually worked as Grade-II(DSS)/ASO.

The above mentioned officials will continue to work in the same department to the post of Grade-II(DSS)/ASO, as usual.

The Head of Departments concerned shall ensure that the aforesaid officials are clear from vigilance angle and no penalty was in operation on the date of their notional promotion. Further, an undertaking in this regard shall also be obtained from the officials concerned.

If the above officials are not clear from vigilance angle or their integrity is not certified on the date of notional promotion, the same should be brought to the notice of this department immediately.

The promotion shall be subject to outcome of further orders that may be passed by the Hon'ble Supreme Court in the case of Jarnail Singh & Others (Civil Appeal No.629 of 2022) arising out of SLP (C) No.30621/2011, as conveyed by the DoPT vide OM No.36012/16/2019-Estt.(RES) dated 12/04/2022.


