The official may exercise option with regard to fixation of pay, if any, as per FR22 within one month from the issue of this order.

However, the financial benefits will be admissible to the above mentioned official with effect from the actual date of joining to the post of Grade-II/ASO and no arrear will be allowed for the period he has not actually worked as Grade-II/ASO.

Further, consequent upon his promotion to the post of Grade-II(DSS)/Assistant Section Officer, the above official will continue to work in his present department, i.e., GBPH against vacant post of Grade-II(DSS)/Assistant Section Officer with immediate effect.

The promotion is subject to the condition that the Head of the Department concerned must ensure that no disciplinary proceeding/criminal proceeding is pending or no penalty was in operation against the promottee official on the date of his notional promotion before relieving him to take up new assignment on promotion in the light of instructions contained in DoPT O.M.
