The official concerned may be allowed to exercise option(s), if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.

The concerned Head of Department is requested to ensure before issuing final order that 20 years of regular service of the official does not include the period of service rendered in Autonomous body/Public Sector Organization as the period of past service in these bodies is not to be counted for grant of financial up-gradation under MACP Scheme.
