reau of Indian Standards (BIS) being the National Standards Body of the country discharges multitude of functions and services for enhancing the quality ecosystem in the Country. The activities of BiS include standards formulation at national and international level, conformity assessment schemes (Product Certification, Systems Certification, Registration and Hallmarking) testing and training. All these activities are carried out through their network of headquarters, regional and branch offices and labs spread throughout the country.

During the last two decades, significant number of natural disasters such as earthquakes, landslides, cyclones etc, had occurred in our country leading to a huge loss of life and property. These losses have shown that the built environment was fragile, and needed adequate attention. It has been found that most of the casualties occurred in these devastating events are due to the collapse of buildings and structures, which had no safeguarding features or are not properly designed. This emphasizes the need for taking many initiatives. including strict compliance of municipal bye-laws and design codes in India and creating awareness among concerned stakeholders for implementation of the various provisions in the concerned standards.

Adoption of the latest standards in this field is the key solution to make disaster resilient infrastructure. Design codes must also be effectively enforced to ensure that buildings and their occupants benefit from advances in the provisions and guidelines covered in them.

BIS has formulated a number of standards in the field of disaster mitigation. These standards provide the good practices for structural design of buildings and enhance the resilience and safety of structures during natural disasters. Other standards relating to assessment and retrofitting of buildings provide guidance to improve the structural stability and resilience of the existing buildings. In addition to above, BIS Standards relating to societal safety, such as those for early warning system, planning for mass evacuation etc, are also important to effectively deal with emergency situations. Here are some key standards that contribute to disaster mitigation and management -






