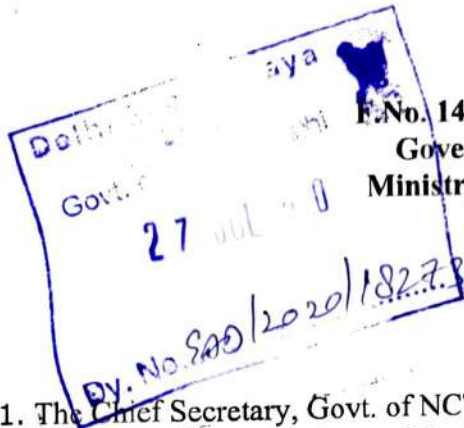

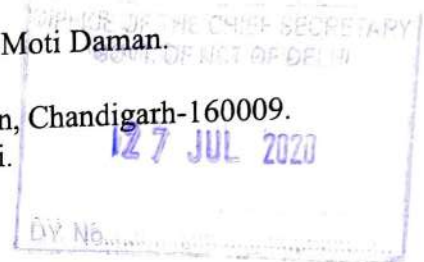

Greetings from Mussoorie!

As you are aware, the Lal Bahadur Shastri National Academy of Administration (LBSNAA) has the mandate to conduct Foundation Training for all officers of Group 'A' Central Services, besides Induction and MCTP Training of all IAS officers.

The training programmes in Academy – both Induction and In-service – are focused on practice and experience- sharing and are coordinated by Joint / Deputy Directors who are on deputation from IAS (to a large extent) and also from other All India and Central Services. In this context, the quality of training, especially Induction Training – is largely dependent on having a capable team of JDs / DDs in the Academy. We need officers who have been successful administrators in the field, and have the qualities of head and heart to inspire the young entrants to Civil Services.

At present, we have five vacancies of Deputy Directors (DDs) in the Academy which need to be filled up urgently. These positions are a part of Central Staffing Scheme, but traditionally Government of India has been kind enough to approve the recommendation of the Director for posting as DDs. In order to encourage the officers to opt for a stint at the Academy GOI has afforded certain additional benefits. Officers are entitled to a training allowance of 24% of the basic pay, provided accommodation within the campus of the Academy and also given priority for nomination to long term foreign trainings sponsored by DoPT. In addition, only half of the time spent in the Academy is counted towards the deputation tenure of five years which also enables officers to do a stint in a Ministry in Delhi during the deputation period.

I would be grateful if these vacancies may be circulated amongst officers of the All India Services (2007 to 2013 batch) in AGMUT Cadre. **I. COMPANY PROFILE**

THDC India Limited formerly known as Tehri Hydro Development Corporation Limited (THDC) was incorporated on 12th July, 1998 under the Indian Companies Act, 1956. The main objectives of the Company are to plan, promote and organize an integrated and efficient development of Conventional/Non-conventional Renewable Sources of Energy and River Valley projects, in India and abroad including planning, investigation, research, design and preparation of preliminary, feasibility and Detailed Project Reports, Construction of such power stations and projects (including consequential environmental protection, afforestation and rehabilitation works), Generating, Transmission & Distribution of Power. THDC India Ltd. is a Schedule 'A' Mini Ratna CPSE with the administrative jurisdiction of Ministry of Power, Government of India.


