The Govt. of Odisha have constituted an independent Regulatory Commission known as Odisha Electricity Regulatory Commission (OERC) with one Chairperson and two other Members under Odisha Electricity reform Act, 1995 and the same continue as such as envisaged in the Electricity Act, 2003.

2. One post of Member of OERC will fall vacant with effect from 04.11.2021. For filling up the post, Govt. have constituted a Selection Committee under section 85(1) of the Electricity Act, 2003.

3. Section 84 of the Electricity Act, 2003 inter alia states that the member of the Commission shall be a person of ability, integrity and standing who have adequate knowledge of and have shown capacity in dealing with problems relating to engineering, finance, commerce, economics, law or management. It has further been prescribed that the member of the Commission shall not hold any other office.

4. As per provisions of the Electricity Act, 2003 the Member, OERC shall hold office for 5 years from the date he/she assumes charge or till he/she attains the age of 65 years whichever is earlier.

5. The Member is entitled to get a pay of Rs. 2,11,600/- per month. In addition, he/she is further entitled to DA and other allowances as admissible to the Member of the Commission as per the Odisha Electricity Regulatory Commission (Conditions of Service of Chairperson and members) Rules, 1997 and amendments thereon from time to time.

6. Therefore, applications from interested and eligible candidates for the above post along with other relevant information in plain paper as mentioned below are invited so as to reach the Principal Secretary to Govel, Energy Department, Govt. of Odisha, Kharavel Bhawan, Bhubaneswar by Regd.
