The post of the Director, NDRF Academy, created with the approval of the Union Cabinet in May, 2021, is proposed to be filled up on deputation basis (including short-term contract). 2. Job requirements: National Disaster Response Force (NDRF) has been constituted under Section 44 of the Disaster Management Act, 2005, for the purpose of specialist response to threatening disaster situation or disaster. In order to train and keep forces updated for handling of natural disasters including Chemical, Biological, Radiological and Nuclear disasters or disaster like situation in the country; NDRF Academy Nagpur has been created by merger of National Civil Defence College (NCDC) Nagpur in 2018. The Director will be administrative head of NDRF Academy and will perform the duties as may be required to channelize functions of the Academy under the direct supervision of the Director General, NDRF.
