




SC in Botany with Horticulture as a subject from a recognized university/institute : OR</p> <p>(iv) M.SC in Horticulture from a recognized university /institute : OR</p> <p>(v) M.SC. in floriculture and landscaping from a recognized university/institute; and</p> <p>(vi) Eight years experience in Horticulture including ornamental gardening and including two years administrative.</p> <p>The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputations shall not be eligible for consideration for appointment by promotion.</p> <p>(Period of deputation (ISTC) including period of deputation (ISTC) in another Ex-cadre post held immediately preceding this appointment in the same or some other organization/ Department of the Central Govt. shall ordinarily not exceed four years. The maximum age limit for appointment by deputation (ISTC) shall not be exceeding 56 years as on the closing date of the receipt of applications).</p>

Note: For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 01.01.2006 date from which the revised pay structure based on 6th CPC recommendation has been extended, shall be deemed to be service rendered in the corresponding Grade Pay / Pay Scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common Grade Pay/Pay Scale, and where this benefit will extend only for the post (s) for which that Grade Pay/ Pay Scale is the normal replacement grade without any up-gradation.


