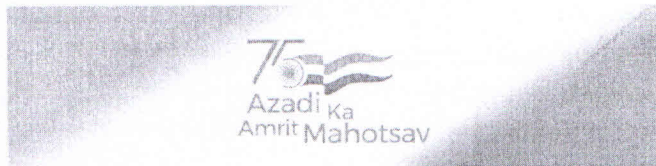

**VACANCY CIRCULAR**

**SUB: - Filling up of vacant post in Wildlife Crime Control Bureau – reg.**

The Wildlife Crime Control Bureau (WCCB) is a multidisciplinary statutory body constituted under the Wild Life Protection Act, 1972, for combating organized wildlife crime in the country. The Bureau HQ is located in New Delhi and it has five Regional Offices (New Delhi, Mumbai, Jabalpur, Chennai, Kolkata), three Sub Regional Offices (Amritsar, Cochin, Guwahati) and five Border Units (Gorakhpur, Motihari, Nathula, Moreh, Ramanathapuram). The posts sanctioned in the Bureau are to be filled by the officers on deputation.

2. The following post are vacant at present or are likely to fall vacant in near future:-


(i) Public Prosecutor = One post

3. The eligibility criterion, classification of post, location of vacancy and pay scale is enclosed as **Annexure-1**. The application form is enclosed as **Annexure-2**.

1. Vigilance Clearance will not normally be granted for a period of 3 years after the currency of punishment, if a minor penalty has been imposed on an officer. In case of imposition of a major penalty, Vigilance clearance will not normally be granted for a period of 5 years after the currency of punishment in terms of DOP&T O.M. No. 11012/11/2007-Estt(A) 14/12/2007.
2. While forwarding applications in respect of officers who are about to complete their 'cooling-off' period shortly the instructions of DOP&T as contained in O.M. No. 2/1/2012-Estt(Pay II) dated 04/01/2013 may be strictly adhered to.
